## To Those Requesting Financial Aid or Scholarships:

Triboro Youth Theatre is a non-profit organization whose primary concern is the welfare and well-being of children. Our policy is that no child be turned away due to the family's inability to pay the membership fee. To that end, we have established payment plans to spread out the cost over the length of the production. We also offer financial aid by giving partial and occasionally full scholarships. The money for these scholarships comes from grants from the **Massachusetts Cultural Council** and the **Lloyd G. Balfour Foundation**.

To prove that there is a need for a scholarship, we ask that you provide TYT with a copy of your most recent IRS 1040 tax summary and write a brief narrative detailing the level of need. These forms are confidential and will only be seen by the Treasurer and the Chairperson of the Board of Directors.
